Mayor Compton spoke about the Americana review provided by Keith Weiskittle earlier this evening during Work Session.

Mayor Compton spoke about ribbon cuttings last week at SOMA Jiu-Jitsu and Southern Vintage Design.

Mayor Compton spoke about Boomerfest and the 40th Anniversary of St. Leonard over the weekend.

Mayor Compton told about a beautiful photo he was able to take at sundown at the Celebration Sculpture and Cornerstone Park.

Mrs. Rau mentioned the Community Improvement Corporation will meet on Wednesday this week.

Mrs. Rau invited Mr. Erik Collins to speak about the City's partnership with Rebuilding Together Dayton. Mr. Collins explained the program provides funding for property maintenance issues for people in need of assistance.

Mr. Engert announced Centerville-Washington History's annual fundraiser Sense of Taste is scheduled for September 7. Tickets are available online.

Mr. Engert announced the 25th Kalaman Golf Outing is scheduled for September 15 at Yankee Trace. Go to the Yankee Trace website to sign up.

Mr. Lunsford encouraged people to attend the Brass Tracks concert on August 27 in Stubbs Park.

Mayor Compton praised Police Department and Public Works staff for all their hard work during the concert season.

In the City Manager's Report, Mr. Davis spoke about:

- Stubbs Park Phase I is out for bid.
- Yankee Trace Patio Expansion is out for bid.
- Touted attendance at the concerts and Party in the Park; he offered praise to the Police Department, Public Works, and Drew Simon.
- Provided electric aggregation opt-out statistics; overall there is a 95 percent participation rate.
- Records Commission meets on Wednesday.
- The TechCred program through the State providing reimbursement funding toward technical certification training.

New Business

A. PUBLIC HEARING: Application P-2023-0015: Amendment to the Final Development Plan Phase 5.

Applicant: Robert L. Hall III, Oberer Land Developers Ltd.

Location: 1001 Belfast Drive et al.

Mr. Vanness presented the case, including site location and zoning, the application summary, the standards of approval, and staff analysis. He noted that Planning Commission recommended approval 6-0 with the following two conditions:

- 1. The Final Development Plan's original eighteen (18) conditions of approval shall remain in place.
- 2. Stone water tables shall be placed on the side and/or rear façades of elevations that face a public right-of-way for the following buildings, 1, 4, 5, 6, 7, 26, 27, 28, 30, 31, 33, 35, 37 and any additional buildings with façades visible from a public right-of-way to the satisfaction of City Staff.

Mr. Vanness explained, after site review with the developer, staff is recommending a modification to condition #2. He provided a comparison of the change.

Mayor Compton opened the Public Hearing.

Mr. George Oberer, Jr. addressed City Council representing Cornerstone Developers. Mr. Oberer discussed cost increases and interest rate increases. He indicated his agreement with the stated conditions.

Council members inquired about material costs and the availability of upscaling for interested buyers.

Mayor Compton closed the Public Hearing.

Mrs. Rau requested Unit #29 be changed in Condition #2 to have full water table wrapping.

Mrs. Rau made a motion to approve Application P-2023-0015 with Condition #1 as recommended by Planning Commission and with modified Condition #2 and with the requested change to Unit #29. Mrs. Kenley seconded the motion, and it passed with 6 ayes.

B. Emergency Ordinance 10-23, An Ordinance Approving Individual Assessments Amounts And Directing The Director Of Finance Or His Designee To Certify The Amounts To The County Auditor For Collection And Declaring An Emergency.

Mr. Roark explained this Ordinance is to conduct the semi-annual collection assessment process.

Mr. Palcher sponsored Ordinance 10-23 and moved for its approval. Mr. Lunsford seconded the motion, and it passed with 6 ayes.
