Mayor Compton called the Work Session meeting to order at 5:40 P.M.

### **Executive Session**

At 5:40 p.m., Mr. Palcher made a motion to move into Executive Session to consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee, or official, to consider the purchase of property for public purposes, for a conference with an attorney for the City, concerning disputes involving the City that are the subject of pending or potential court action and to prepare for, conduct, or review negotiations or bargaining sessions with public employees concerning their compensation or other terms and conditions of their employment. Mrs. Kenley seconded the motion, and it passed 6-0 in a roll call vote.

Finance Director Tyler Roark, Public Works Director Pat Turnbull, City Engineer Jim Brinegar, Assistant City Engineer David Swanson, Communications Director Kate Bostdorff, Human Resources Director Jen McCormick, and IT Director Ryan Collins joined the meeting at this time.

#### City Council Meeting Agenda Review

City Council reviewed the items on tonight's regular meeting agenda.

#### **Stubbs Park Improvements Bid Review**

Mr. Swanson provided an explanation of the criteria used to evaluate each of the submitted bids and to reach a conclusion about the lowest and best bidder. He noted the chosen bid was based on the City's excellent experience with the contractor. Mr. Swanson also discussed issues that are anticipated if two separate contractors are used to complete the project and added that the project consultant, MKSK, recommends against it.

Mr. Liberman handed out a memo and explained the discretionary review criteria allowed by the City's Municipal Code and the bid documents.

Council members discussed attendance at the pre-bid meeting, the make-up of the bid specifications, concerns over accountability issues if two separate contractors are used, the review criteria, and the staff recommendation as to which contractor was lowest and best based on that criteria.
