Mayor Compton mentioned the retirement of Washington Township Trustee Dale Berry.

### **New Business**

A. PUBLIC HEARING: Application P-2023-0032: Conditional Use.

Applicant: Naimish Patel and Maulik Patel, Alphabet of Centerville LLC.

Location: 1180 E. Alex Bell Road.

Mr. Vanness presented the application summary, the site plan, the standards of approval, staff analysis, and next steps. He noted that Planning Commission recommended approval with six conditions in a 5-0 vote. Mr. Vanness advised he is recommending a modification to Condition #3 to read, "A landscaping plan shall be included in the final Minor Site Plan application that includes at least fifteen (15) evergreen trees for every 100' in the side (east) and rear (south) yards to the satisfaction of the City Planner."

Mayor Compton opened the Public Hearing.

Applicant Naimish Patel explained the company's decision to locate in Centerville. He invited Mr. Bada Hong, Lightbridge Academy representative, to speak about the company. Mr. Hong provided a company overview.

Council members discussed the number of facilities which are located near residential areas, infant to older student ratios, the total number of classrooms, quiet times, capacities and normal occupancy, urban to suburban ratios, and the frequency of facility failures/closures.

Council members discussed the minor site plan process, the location of buffering trees, noise level limitations and compliance monitoring, lighting requirements and current compliance, and drainage concerns.

Mr. Patel and Mr. Hong provided rebuttal and additional information in response to the opposition comments.

Council members discussed sibling quantities, drop off/pick up timing, and occupancy limitations.

Hearing no one else come forward, Mayor Compton closed the Public Hearing.

Council members discussed the efficacy of the proposed noise mitigation efforts and light trespassing mitigation.

Mr. Vanness suggested a modification to Condition #2 to include a line-of-sight diagram from Ambridge Road.

Mr. Lunsford made a motion to approve Application P-2023-0032 with Conditions #1, 4, 5 and 6 as recommended by Planning Commission, with Condition #2 modified to read "A full photometric lighting plan and a line-of-sight diagram from Ambridge Road shall be included in the final Minor Site Plan application. The applicant will then work with staff to lower the photometric aspects of the lighting, which may include lowering the height of the light poles, and/or shielding, and/or reducing the number of light poles to the minimum allowed to the satisfaction of the City Planner and City Engineer," and with Condition #3 modified to read "A landscaping plan shall be included in the final Minor Site Plan application that includes at least fifteen (15) evergreen trees for every 100' in the side (east) and rear (south) yards to the satisfaction of the City Planner." Mrs. Rau seconded the motion, and it passed 3-2 in a roll call vote with Mr. Lunsford and Mr. Engert voting no.

B. Resolution 106-23, A Resolution Adopting The 2024-2028 Capital Improvement Program For The City Of Centerville, Ohio.

Mr. Roark explained that the Capital Improvement Program includes \$17.5 million in total capital projects.

Mrs. Kenley made a motion to approve the Capital Improvement Program Resolution. Mrs. Rau seconded the motion, and it passed with 5 ayes.

C. Ordinance 22-23, An Emergency Ordinance To Amend Ordinance Number 13-23 To Make Appropriations For The Current Expenses And Other Expenditures Of The City Of Centerville, State Of Ohio, During The Fiscal Year Ended December 31, 2023.

Mr. Roark explained that this Ordinance is the final clean-up of the current year budget. He provided explanations for fund increases and decreases.

Mr. Engert sponsored the Ordinance 22-23 and moved for its approval. Mr. Lunsford seconded the motion, and it passed with 5 ayes.

#### **Old Business**

A. PUBLIC HEARING: 2024 Operating Budget.

Mr. Roark provided the budget presentation, covering the budget process, 2023 and 2024 budget summaries, revenue and expense projections, the capital improvement program, State legislation impacts, and 2024 goals.

Mayor Compton opened the Public Hearing.

Hearing no one come forward, Mayor Compton closed the Public Hearing.

Mrs. Rau moved to adopt the 2024 Operating Budget. Mr. Engert seconded the motion, and it passed with 5 ayes.

B. PUBLIC HEARING: Ordinance 20-23, An Ordinance To Make Appropriations For The Current Expenses And Other Expenditures Of The City Of Centerville, State Of Ohio, During The Fiscal Year Ended December 31, 2024.

Mr. Roark explained this Ordinance gives staff the authority to spend the funds approved in the 2024 Operating Budget.

Mayor Compton opened the Public Hearing.

Hearing no one come forward, Mayor Compton closed the Public Hearing.

Mrs. Kenley sponsored the Ordinance 20-23 and moved for its approval. Mr. Lunsford seconded the motion, and it passed with 5 ayes.

C. PUBLIC HEARING: Ordinance 21-23, An Ordinance To Repeal Ordinance Number 24-22 In Its Entirety And Adopt All Fees, Rules And Regulations Associated With The Golf Club At Yankee Trace.

Mrs. Vogelgesang noted that all fee increases were less than 10 percent. The Ordinance focuses on policy language changes.

Mayor Compton opened the Public Hearing.

Hearing no one come forward, Mayor Compton closed the Public Hearing.

Mrs. Kenley sponsored the Ordinance 21-23 and moved for its approval. Mrs. Rau seconded the motion, and it passed with 5 ayes.

### Consent Agenda

Mayor Compton turned the attention of the group to the Consent Agenda. Any City Councilmember may remove an item from the Consent Agenda by request. No second is required for removal of an item.
