Applicant: Brent Myers, Casto on behalf of Valvoline

Location: 6238 and 6240 Far Hills Avenue

Mr. Vanness provided the staff report, covering the case background, application summary, and standards of approval. He noted Planning Commission voted to recommend approval with the following three conditions:

- 1. Prior to the release and recording of the Record Plat, all review comments from public and utility review agencies shall be addressed to the satisfaction of the City Planner and City Engineer.
- 2. Prior to the release and recording of the Record Plat, the final zoning permit shall be approved and issued.
- 3. Prior to the release and recording of the Record Plat, all improvements in the public right-of-way shall be financially secured by a performance bond for 110% of all

improvements to the satisfaction of the City Engineer.

Mr. Brent Myers, representing Casto, addressed City Council expressing their desire to combine the two parcels and noting they take no issue with the conditions.

Mrs. Rau moved to approve the record plat. Mr. Palcher seconded the motion and it passed with 7 ayes.
