The commission discussed moving the date to September or April after Drew discusses with Centerville-Washington History.

An update on the July 12 Party in the Park was given by Terry O'Brien and Drew. The last Party in the Park for the year is the Garth Brooks tribute in August.

Miami Valley Community Concert Association concerts start September 15. MVCCA and Centerville will discuss setting up a plan for this season.

Uptown Music had about 60 people at the last performance.

Cornerstone Music had around 20-40 people at latest concerts. Rich LaRue noted the water feature is a problem with video records due to the sound.

The plan for next year may be to have larger groups at Cornerstone and smaller ones at Uptown

The final Summer Concert Series show had about 3,390 people in attendance.
