ORDINANCE NO. 24-24 CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER <u>Mark Engert</u> ON THE <u>21</u> DAY OF <u>October</u>, 2024.

AN EMERGENCY ORDINANCE AUTHORIZING THE PURCHASE OF A USED LABRIE AUTOMIZER RIGHT HAND DRIVE AUTOMATED SIDE LOADER FROM BEST EQUIPMENT CO INC. AND FURTHER AUTHORIZING THE CITY MANAGER TO TAKE ALL STEPS NECESSARY TO FACILITATE SAID PURCHASE.

WHEREAS, Centerville Charter Article VII, Section 7.07 requires competitive bidding and other procedures be established by the City by ordinance consistent with the Charter for the purchase of all supplies, materials, and equipment; and

WHEREAS, the City Council is allowed to establish other purchasing procedures by ordinance; and

WHEREAS, the City typically utilizes Automated Side Loader (ASL) trucks to pick up waste and recycling within the city; and

WHEREAS, the City was in pursuit of a new ASL to replenish its fleet; and

WHEREAS, the City became aware of a used ASL that closely matches the city's specifications and that was in great physical condition, but no longer needed by another jurisdiction; and

WHEREAS, the purchase of the used ASL would provide for expedited delivery of a usable unit at a large savings from the current Sourcewell contract pricing; and

WHEREAS, the current Sourcewell contract pricing is \$436,020.60, but Best Equipment Co Inc., is willing to sell the City the ASL for the price of \$385,000, plus freight for delivery, saving the City \$50,000, and allowing for the expedited delivery of the equipment; and

WHEREAS, City Council has determined that it is in the best interests of the City to purchase the used Labrie Automizer Right Hand Drive ASL from Best Equipment; and

WHEREAS, City Council desires to facilitate this purchase immediately in order to both utilize the cost savings and the expedited timing for receipt of the truck.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. The City of Centerville hereby authorizes the purchase of a Labrie Automizer Right Hand Drive Automated Side Loader at a cost of \$385,000 from Best Equipment Co Inc.; and hereby authorizes the City Manager to take all steps necessary to facilitate this purchase of surplus from that political subdivision.

Section 2: This ordinance is hereby declared to be an emergency measure and shall become effective immediately upon passage. An emergency affecting public health, safety and welfare is hereby declared to exist by virtue of the fact that the City desires to move forward with the purchase of equipment immediately needed for the City, at a cost savings and having the ability for a quicker delivery of the truck to put into use faster.
