AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE
USED TYMCO MODEL 600 STREET SWEEPER
MOUNTED ON A 2023 FREIGHTLINER M2-106 DUAL
STEER CHASSIS FROM BEST EQUIPMENT CO INC AND
FURTHER AUTHORIZING THE CITY MANAGER TO TAKE
ALL STEPS NECESSARY TO FACILITATE SAID PURCHASE.

WHEREAS, Centerville Charter Article VII, Section 7.07 requires competitive
bidding and other procedures be established by the City by ordinance consistent with
the Charter for the purchase of all supplies, materials, and equipment; and

WHEREAS, the City Council is allowed to establish other purchasing
procedures by ordinance; and

WHEREAS, the City was in pursuit of a Tymco Model 600 Street Sweeper
mounted on a 2023 Freightliner M2-106 Dual Steer Chassis to replenish its fleet;
and

WHEREAS, the City became aware of the Tymco Model 600 Street
Sweeper mounted on a 2023 Freightliner M2-106 Dual Steer Chassis that closely
matches the city's specifications and that was in great physical condition and is on the
State of Ohio STS contract #800936; and

WHEREAS, the purchase of the used street sweeper would provide for
expedited delivery of a usable unit at a large savings from the current STS contract
pricing; and

WHEREAS, the current STS contract pricing estimate is \$339,433.25 through
Best Equipment Co Inc; and

WHEREAS, City Council has determined that it is in the best interests of the
City to purchase the used Tymco Model 600 Street Sweeper mounted on a 2023
Freightliner M2-106 Dual Steer Chassis from Best Equipment; and

WHEREAS, City Council desires to facilitate this purchase immediately in
order to both utilize the cost savings and the expedited timing for receipt of the truck.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY
ORDAINS:

Section 1. The City of Centerville hereby authorizes the purchase of a used Tymco Model 600 Street Sweeper mounted on a 2023 Freightliner M2-106 Dual Steer Chassis at a cost of \$339,433.25 from Best Equipment Co Inc; and hereby authorizes the City Manager to take all steps necessary to facilitate this purchase.

Section 2: This ordinance is to go into effect at the earliest time allowed by law.
