  - o Provided an update on the tree grant project
    - All initial contract tree removals are complete and the additional work in Stubbs Park is underway.
    - Pricing for trees has been secured and PO's are being prepared. Trees types to be planted include:
      - Ornamental types trees that meet the requirements of the 'Right Tree Right Place' guidelines will be planted along East Franklin and on north Main under the power lines. These types include Red Baron crabapples, Adirondack crabapples, and Ivory Silk Lilac trees.
      - The 'shade' trees to be planted at various locations around town include English, Sawtooth, and Crimson Spire oaks, Gingko, Quaking Aspens, Hackberry, Tulip Poplar, Chestnut, White Fir, Osage Orange, and Crimson King Maple trees.
